The highlight of this Newsletter edition is the enclosed schedule of lectures and tours for next semester. Our Curriculum Committee has developed another wonderfully eclectic line-up of lectures and tours. Many thanks to Chuck Johnson and Joe Alfred for their leadership and to each of the sponsors for coming up with the ideas, selecting the best of the best, developing course descriptions, and for shepherding and introducing our guest speakers.

Congratulations to Treasurer John Thompson for again scoring a "clean" financial audit. Our thanks to Wendell Anderson who volunteered his time and expertise in conducting the audit, thus ensuring the ElderStudy Financial Program remains in outstanding shape.

December is the month in our annual operations cycle when we seek the general membership's nominations for election of three members to serve three-year terms on the Board of Directors. Retiring Board members Randy Fennemore, John Thompson and myself constitute the Nominating Committee. We will consider all names submitted to us by you, and will also solicit other nominees as needed to sustain our organization. No one will be nominated without his/her prior consent. We need your nominations no later than Friday, January 22nd in order to allow time to gather a short biographical sketch and photo so that Dottie Meyers can publish those in the February ElderStudy newsletter. Nominees will be voted on at our March 16th General Membership Meeting.

After several years of dedicated service, both Pat Parkinson and John Thompson have asked that we find replacements for them next year as Chairs of Membership and Administration Committee. As President, I have the responsibility to identify and present for the Board's approval their replacements, and am still in need of a capable volunteer to replace John. This is a rewarding, yet demanding position and we need to find someone willing to get involved in learning how our organization operates. Subject to the Board's approval, John's willing to serve a bit longer as Treasurer, but is also willing to "turn over the books" if someone capable is interested. You must be able to balance a checkbook and keep records of receipts and expenditures. Your assistance in finding the right person would be greatly appreciated, and self-nominations are great too.

Administration Committee and Treasurer's Reports

The Administration Committee held its most recent quarterly meeting on November 24th in the Center For Lifelong Learning. A Tentative Agenda was issued about two weeks in advance of the meeting; this agenda was also posted on the ElderStudy website.

The Treasurer provided preliminary financial reports for the period from September 1 to November 23. Income from membership fees slightly exceeds the amount necessary to fully-fund the approved 2015-2016 budget. Additional new memberships are anticipated in December and January. When the First Quarter Financial Reports are approved by the Board of Directors at its December 2 Quarterly Meeting, they will be posted on the ElderStudy website and will be provided to our University Representative in accordance with the Memorandum of Understanding with the University.

Under New Business, the Committee received a preliminary report regarding the 2014-2015 Annual Audit conducted by Member Wendell Anderson. This audit did not reveal any deficiencies in the ElderStudy financial system. Upon approval of the Audit Report by the Board, the Treasurer will file the ElderStudy Federal Tax Return for the period September 1, 2014 to August 31, 2015.

Also under New Business, the Committee developed a recommendation regarding the BLS Scholarship to be provided to the University for the 2016-2017 academic year. The recommended amount is consistent with the approved budget. Approval of the recommendation will be requested at the December 2 Board Meeting.

The next meeting of the Administration Committee is scheduled for February 23, 2016 at 1 PM in the Center for Lifelong Learning. ElderStudy Members are welcome to participate.

Five MC volunteers allotted their time have a future subcommittee meeting to upgrade the Membership committee policy and procedure Section G Appendix. Directions are for using Route 1 starting from Exit 126 off of I-95.

Go south on Route 1 for approximately 1 mile

Turn right onto Spotsylvania Parkway (CVS Pharmacy is on corner)

At second traffic light (approximately 2 miles), turn left onto Smith Station Road.

YMCA is located 1.2 miles on right.

Once at the YMCA, check in at the front desk and get directions to the gymnasium.
