CURRICULUM COMMITTEE REPORT

We are well into our spring schedule and our programs have been educational and most interesting. First time speakers at Mary Washington ElderStudy include: Dr. Troy Paino, who gave us his perspective on higher education in an age of accelerations and Jagadish Tadepalli, who gave us his perspective on Heartfulness. The attendance has been excellent, several programs with 60 plus members. We have 39 programs in preparation for the fall 2018 schedule, including 7 Tours, 4 Book Groups and 2 Play Discussions. We have booked 12 of our fall 2018 programs with firm dates.

The next Curriculum Committee meetings are scheduled for February 15 and March 15. We have an enthusiastic crew of sponsors who submitted 12 program proposals before our January meeting began. We are always looking for that next new idea in our journey to lifelong learning. The ElderStudy Operations Report for the first three months of the 2016-2017 Year (September thru November) is enclosed with this newsletter. As of January 15, the number of paying members has increased to 301, compared with 272 at this time last year. 
