ADMINISTRATION COMMITTEE

MEMBER PARKING IN THE COLLEGE HEIGHTS AREA

For the past two years, ElderStudy has tried to take a common sense approach that would allow ElderStudy members to park on the "Resident Only" designated public streets within the College Heights area.

The City Ordinance that covers parking in the College Heights area is Sec. 58-201.

Sec. 58-201. Purpose and intent.

In order to reduce hazardous traffic conditions resulting from the use of streets within residential areas for commercial parking; to protect such residential areas from polluted air, excessive noise and trash and refuse caused by the entry of such vehicles; to protect the residents of such areas from unreasonable burdens in

gaining access to their residences; to preserve the character of those areas as residential districts; to promote efficiency in the maintenance of those streets in a clean and safe condition; to preserve the value of the property in such areas; and to preserve the safety of children and other pedestrians and traffic safety; a permit parking program is hereby established.

(Code 1991, § 12-96)

In June 2009, Phil Hall attended a meeting of the College Heights Civic Association (CHCA). At that time we were told they were "agreeable and sympathetic" but there was nothing they could do.

Sec. 58-204 authorizes the City Manager to establish the criteria by which persons may obtain temporary parking passes. This is in addition to hardship cases. With an average age of our membership in the early to mid 70's, we felt that our overall situation justified our request.

Members of our organization then met with or spoke with the Chief of Police, other city employees, and a knowledgeable City Councilman who were also sympathetic, but stated that a waiver must be granted by the City Manager.

In April 2010 I elected to personally address the parking situation with the City Manager. My initial action was to write a letter to Beverly R. Cameron, City Manager. Highlights of that letter are as follows -

In accordance with Sec. 58-201 and Sec. 58-204 of the Fredericksburg City Code, Mary Washington ElderStudy requests a limited waiver for on street parking as described in Sec 58-203 within the College Heights area.

With an average age of our membership in the early to mid 70's, I feel that our overall situation justifies our request. We are the only active campus activity that involves seniors that may find it difficult to walk greater distances yet do not qualify for handicapped parking.

- Mary Washington ElderStudy is a Learning in Retirement program at the University.
- ElderStudy is an independent all-volunteer, nonprofit organization that provides low-cost educational opportunities for those who want to continue learning

Given our average class attendance and the actual number of members that would utilize ElderStudy parking permits, impact on the streets within the College Heights area would be negligible.

To negate any impact on City staff, we would have the temporary no-fee permits printed and manage the program.

Mr. Cameron responded to my May letter on September 2nd inferring that that it would be a waste of time to discuss this further and no waiver will be granted. Mr. Cameron's letter also states the CHCA's statement of position is of "strong opposition to the proposal." This is in direct conflict to what we were told and what should be in the Associations' minutes of their June 2009 meeting.

On September 15th I wrote to Mayor Tomzak noting "It is a sad state of affairs when senior citizens, who want to continue their education, find it difficult because a homeowners group will not allow *limited daytime parking* on *public streets*. Given our average class attendance, the impact on College Heights' homeowners' would be negligible and since ElderStudy would provide hangtags and manage the program, the city would not be impacted at all." I specifically noted that "One of the two provisions for implementing permit parking (Sec. 58-204) is that more than 75% of the parking spaces available on such blocks are occupied during any hours of any 14 days in a 30-day period. Providing ElderStudy a limited waiver for parking would not cause that requirement to be exceeded."

To date, the Mayor has not responded to my September 15th letter. Copies of all three letters are posted on our Bulletin Board in Chandler 102.

Subsequent conversations with City Councilmen Mr. Howe and Mr. Solley have indicated that we are being held hostage in an attempt by the College Heights Association to negotiate (?) with the University. Unfortunately, there appears to be a very strained relationship between the Association and the University.

In closing, I would quote from a letter from Dr. Wilder, UMW Chief of Staff to two of our members: "Please know that, while the ElderStudy Program is provided with meeting space on our campus and other considerations, it is an independent, community-based organization. Therefore the University does not have any direct involvement in the activities of the group or its programs. (Note: This is all covered in our Memorandum of Understanding with the University that can be found in the *Procedures Manual*.)

I assure each of you, that we will continue to pursue an equitable and common sense solution.

LIFELONG LEARNING AFFILIATION

ElderStudy is one of many "Lifelong Learning Institutes" or LLIs. Each LLI (previously referred to as Institutes for Learning in Retirement – ILR's) is sponsored by an educational institution and has a distinctive name. Mary Washington ElderStudy was organized under a Letter of Understanding between Mary Washington College and the Elderhostel Institute Network (EIN) dated October 21, 1992. In the fall of 1993, ElderStudy was accepted as an affiliate member of the Elderhostel Institute Network. Today, there are over 350 Lifelong Learning Institutes located at Universities and Colleges worldwide. From its humble beginnings in 1962, the Elderhostel Institute Network has become a dues-free, "virtual" organization, providing services from a special section of the Elderhostel website.

PREPARATION OF THE ELDERSTUDY 2011-2012 BUDGET

In accordance with the ElderStudy *Procedures Manual*, the ElderStudy Budget for the organizational year (September 01 thru August 31) is prepared in the spring of each year by the Administration Committee. The proposed budget is then presented to the Board of Directors at the June Board of Directors meeting. To meet the schedule as outlined in the *Procedures Manual*, inputs from the Board of Directors and each standing Committee Chairperson should be provided in writing by April 15th.
